1. It has been observed that many CP notices are received at this HQ at short notice. Neither Para 43 documents nor any reference regarding the case/CP would have been received at this HQ till that time leaving with very little time to take action in such cases, thereby leading to unwarranted embarrassment. This needs to be seriously addressed at all levels.
2. With the above perspective, DG (Pers) has viewed this criticality seriously and has directed that a presentation on all court cases pertaining to AOR / Jurisdiction be given at this HQ.
3. In view of the above, all CEs Command / ADGs are requested to fwd a detailed presentation on all court cases in Power Point format (separately for E1C (Legal) and E1 Legal (O)) alongwith its soft copy through email at dydire1cl-mes@gov.in by **22 Mar 2021** as per enclosed format.
